Sound Choice has put together a FetalFree<sup>™</sup> certification program so that consumers can be easily informed that the products they want to buy do not contain contaminants or material from aborted fetuses. What products are of concern? Cosmetics and anti-ageing creams, drugs and vaccines, and foods and beverages. This is a concern to consumers regardless of their position on women's reproductive rights or embryonic stem cell research. Who wants to unknowingly rub aborted fetal contaminants on their face? Who wants to unknowingly inject their children with aborted fetal DNA contaminants in vaccines? We all want to choose those products that are not tainted with these contaminants. But we cannot choose the better product until we know which products are safe to purchase.

### PepsiCo capitulates to an international boycott and stops using aborted fetal cell lines for new product discovery.

Just a few weeks after biotech met in Seattle last April to develop commercial strategies to reduce, remove and replace aborted fetal material in commercial products PepsiCo capitulated and agreed to stop using aborted fetal cell lines to discover new additives and flavor enhancers. One of our board members, Debi Vinnedge, led an international boycott effort against PepsiCo Sound Choice Pharmaceutical Institute Education . Scientific Research . 
because they refused to stop using aborted fetal cell lines. When enough people just said "NO" to PepsiCo, they capitulated. They were hurt economically and this allowed them to see the light and do the right thing. Who said we can't make a difference? Of course we can!

Sound Choice has assembled the four necessary categories of data to support human fetal material contaminating vaccines as a major environmental trigger behind the autism disorder epidemic.

The four necessary characteristics of any environmental toxin to be responsible for human disease epidemics include : the toxin should not have been present before the start of the epidemic, the toxin should have an apparent dose-effect, the toxin should have a biological mechanism of action compatible with the disease, and broad or universal exposure to the toxin must have occurred.

1. In the US autism disorder began to rise in 1980, just after they started manufacturing the childhood MMR II vaccine using aborted fetal cell lines. Before aborted fetal contaminants were present in childhood vaccines regressive autism disorder was unheard of. Aborted fetal contaminant toxins were not present before the start of the autism epidemic.

2. In 1988 autism disorder rose again, right after they doubled the number of children vaccinated with aborted fetal cell produced MMR II and right after they added a second dose to the immunization schedule. In 1995 autism disorder took another steep rise right after aborted fetal cell contaminated chickenpox vaccine was introduced. The number of children who are vaccinated with the heavily contaminated chickenpox vaccine predicts the number of children who will be diagnosed with autism disorder. You can see this highly significant relationship in the graph below.



3. Fetal DNA contaminants are known to be able to insert into DNA and could disrupt gene function and cause mutations in our

children. In 2011 and 2012 over 30 top academic universities have published data showing that children with regressive autism have hundreds of new mutations that are not inherited from their parents genes. The FDA has been worried about DNA insertions since they first approved using aborted fetal cell lines to make vaccines. Worry is not enough when our children are at stake. Sound Choice is doing the studies to determine the real and present dangers of this known biological mechanism for pathology.

4. Children are universally exposed to these aborted fetal produced vaccines. The media publishes stories about the numbers of parents who refuse vaccines, the disease outbreaks we are seeing, and the fact that autism has continued to increase, implying that vaccines are unrelated. What the news does not report, however, is that parents tend to refuse only one or two of the up to 36 vaccines their children receive. Parents have been refusing vaccines they believe contain mercury, not the aborted fetal produced vaccines, so of course autism has continued to rise. Today, children receive up to 10 jabs with aborted fetal contaminated vaccines, starting as early as 2 months of age.

In 2012 biotech executives joined Sound Choice in Seattle for the first ever strategic planning meeting to reduce and replace the use of aborted fetal material in commercial products.

Last April we were thrilled to host a dozen biotech executives who came together to share ideas about the most efficient way to reduce, remove and replace aborted fetal cells from commercial products. The excitement of this critical planning meeting translated immediately to action. At least 3 other companies have already joined ΔVM Biotechnology in the ranks of companies actively working and developing alternative biomedical products free from the taint of aborted fetal material. WOW! In 2013 we hope to announce that even more companies have pledged to eliminate aborted fetal material from their practices and products. We can do it; we can keep this crucial momentum going with your help.

## Adult stem cells draw Nobel Prize attention.

While mainstream media may have deceived the American public into believing that embryonic stem cells are the magic bullet for human disease, the 2012 Nobel Committee isn't buying it. The Nobel Committee drew attention to the fact that adult stem cell therapy is morally acceptable and less affected by immune rejection, in contrast to embryonic or fetal stem cells, and awarded their Nobel prize highlighting adult stem cell research. Because of this, in 2013 we will likely see regulatory approval for moral adult stem cell therapies for several diseases, including heart attack. In contrast, 2011 saw the sudden and unexplained cancellation of Geron Corporation's embryonic stem cell trials, most likely because of adverse effects of the embryonic stem cells.

Adult stem cells are a win-win for everyone, *if they are obtained in a completely moral fashion*. We know of only one company who has made that pledge, AVM Biotechnology. Adult stem cells are safe. They are effective. They are affordable. Safe, effective and affordable, and no other human being has to be harmed - that's a choice that should be a nobrainer, and the Nobel Prize Committee agrees.
